Vehicles granted prior approval to remain on site for medical or business reasons, must remain parked on the designated site for the duration of the event.
4. To be responsible for any damages caused by the vendor or the vendors agents on the premises.
5. To keep designated spot in a clean and tidy state and to remove any unsold articles. Failure to do so may result in additional charges and/or denial to participate in subsequent events.
6. Not to sell or offer for sale or distribution food and/or drinks that are intended for immediate or on-site consumption.
7. Not to sell or offer for sale dangerous and/or hazardous articles.
8. Not to use any type of motorized generator or similar device without express permission being obtained at time of registration.
9. Not to attach or to place anything on or near the grass, shrubs, trees, ports or signs.
